





## **APPLICATION FORM – VOLUNTARY EARLY ENLISTMENT SCHEME**

### **TERMS AND CONDITIONS**

1. Under the Enlistment Act, all male Singaporeans and Permanent Residents are liable to serve National Service (NS) upon reaching 18 years of age. NS-liable males who are 16½ years old and wish to enlist for full-time NS early may apply to do so as a volunteer under the SAF (Volunteers) Regulations through the Voluntary Early Enlistment Scheme (VEES).
2. Persons who volunteer to enlist early under VEES will be put through a medical fitness examination and an aptitude assessment to ascertain whether they are able to cope with military training. Each application will be decided on a case-by-case basis by the Central Manpower Base.
3. Volunteers will serve the same period of full-time NS like other Full-Time National Servicemen (NSFs) who are enlisted when or after they reach 18 years of age. The period of volunteer service under VEES will cease on the day the volunteer turns 18 years old. The period of volunteer service will count towards fulfilment of full-time NS on a 1:1 basis, provided the volunteer does not terminate his volunteer service prematurely.
4. The volunteer may choose to be prematurely released from volunteer service by giving 3 months' notice in writing to his unit. If the volunteer is prematurely released from service, the period of volunteer service will **not** count towards the discharge of NS liability. The volunteer will have to serve the full 24 months of NS duration (or 22 months if he is eligible for the 8-week reduction in full-time NS) upon his eventual enlistment when or after he reaches 18 years of age.
5. Volunteers will be subject to laws and acts, including orders and directives issued by the Singapore Armed Forces, like any other NSF. Their eligibility for NS allowance, annual leave, medical benefits and other benefits will be the same as those accorded to NSFs.
6. Volunteers who are enlisted under VEES will **not** be eligible for disruption from full-time NS to pursue studies of up to GCE 'A' Level, Polytechnic diploma or their equivalent qualifications. Those who seek to pursue further studies of the above stated qualifications can only do so after completion of full-time NS.

8. Applicants should note that they are required to complete all pre-enlistment processes before enlistment. Successful applicants for VEES who have completed their pre-enlistment processes will be scheduled for enlistment in the next available intake, subject to training capacity. As such, applicants may enlist after they are 18 years old, depending on when they complete the pre-enlistment processes and whether there are available slots in the earliest intake based on their assigned Physical Employment Standard (PES).
